#### **Mail conditions**

- Tariffs/Rates are for the Express service, based on a DDP/DDU incoterms
- Tariffs/Rates exclude the return of undeliverable items and exclude customers returns
- Delivery within 3-5 working days from landing and additional of 3 working days in peak period (November and December)
- Home delivery: Surcharge of £2.50 of the attached rates
- VAT threshold 75\$ value. DDU is limited to this value

#### **DDP** surcharges

Custom clearance fee per total value of parcel with value of \$75 and above: £2.75

#### Computer fee (governmental charge):

- Declared value item 100\$-1000\$: £4.45
- Declared value item above 1000\$: £8.84

#### Special customs release fees

- If the value is above 1,000\$ or the import is commercial, or the shipment contain illegal goods, Customs release fee— £32.35
- If ILP requires to obtain special certificate from governmental authority (communication/standard institute) to import a shipment, then shipper will reimburse for the amount paid by ILP equal to — £80.70

#### **Service Restrictions**

#### **Prohibited Items**

Certain items are strictly not permitted for shipment due to international regulations and Israeli import laws. These include:

- Explosives and Hazardous Materials: Fireworks, flares, and other explosive substances.
- Weapons and Ammunition: Firearms, bullets, and related materials.
- Illegal Substances: Narcotics, cannabis products, and controlled drugs.
- Pornographic Content
- Counterfeit Items: Including money, stamps, and intellectual property.
- Endangered Species Products: Items made from protected animals or plants (per CITES agreement).
- Ashestos
- Tobacco and Alcohol: Subject to restrictions or full prohibition.
- Live Animals and Animal Products
- Human Remains or Biological Samples
- Hazardous Waste and Strong Acids
- Perishables: Such as food or temperature-sensitive goods without proper arrangements.
- Currency and Precious Metals

#### **Controlled Goods** (May Require Permits)

Some items can be shipped, but only with the correct approvals from relevant Israeli authorities:

- Pharmaceuticals and Medical Devices
- Agricultural Products: Including plants, seeds, and soil.
- Food Items: Especially meat and dairy.
- High-tech or Dual-use Goods: Electronics, encryption tech, and items with both civilian/military use.
- Cultural or Religious Artifacts
- Chemicals and Chemical Precursors
- Radioactive Materials and Biological Substances

#### Dangerous Goods (Common Examples)

Air transport regulations prohibit many everyday items due to safety risks. These include:

- Nail polish, glue, perfume, lipstick
- Batteries, printer ink, magnetized materials
- · Sprays, dry ice, camping or lab equipment
- Automotive parts, diving or drilling gear
- Vaccines, vapour shippers, certain chemicals

It is the shipper's responsibility to ensure that no dangerous or restricted goods are included in shipments. Packaging and contents must also comply with both Israeli and international transit regulations.
