



De Minimis level

De Minimis is based on the concept of the de minimis level, representing the value below which imported goods can enter without incurring duties and with minimal government scrutiny. The rationale behind this is that for items of low value, it is considered impractical to subject them to regular Customs and Border Protection (CBP) procedures.

USA De Minimis thresholds

Clearance - Type 86 USA


The United States has recently implemented Entry Type 86 in accordance with Section 321 of the Tariff Act of 1930, aiming to streamline the processing of ecommerce shipments. This initiative involves exempting low-value imports from customs duty. For a product to qualify as "low value" its value must be \$800 or less, falling below the U.S. de minimis threshold.


