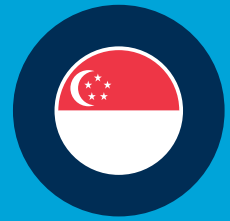

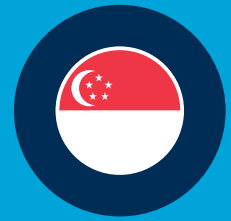

Weight and dimensions



Maximum Parcel Weight: 60 lbs

Maximum Parcel Length: 100 cm

Minimum Parcel Dimensions: 15 cm (L) x 10 cm (H) - (6x4 inches)

Minimum Chargeable Weight: 1 lb

Dimension Factor: Dim weight is LxWxH divided by 166

- i** Shipping weight is the total package weight (product + packing)
Shipping rate is determined according to the actual weight or the dimensional weight, whichever is greater.
Package weights will be rounded to the next weight tier.

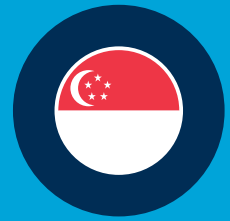

Service Restrictions

Prohibited items:

Alcoholic beverages and tobacco, controlled drugs, non-domesticated animal products, articles of high/unusual value such as diamonds, raw precious stones and metals/bullions, biological substances, human or animal specimens, dangerous goods, electronic cigarettes, firearms and weapons (including inert and replica explosive weapons), furs, gold or other precious metals, live animals or cites-listed wildlife, perishables, personal effects (used/second-hand privately owned items like shoes, clothes furniture), live plants, seeds, tobacco, chewing gum (sg only), prohibited telecommunications equipment, pornographic materials, cloth imprinted of any verses of the Quran, counterfeit trademark goods, fake currency, bonds, or coins, narcotics e.g. marijuana, hemp, opium, cocaine, morphine, heroin, radioactive material.
